Awatea Place Wastewater Pump Station

The construction of the Awatea Place Pump Station is one of Nelson City Council's major projects in the upcoming year. This project will have a direct impact on improving wastewater in the Tahunanui catchment, helping to prevent unwanted overflows and catering for any increased growth in the area. The work will involve the construction of the new pump station and the required pipes to and from the station.

This project has been able to occur thanks to funding received from Central Government under the Three Waters Reform Programme. This funding was part of a Memorandum of Understanding entered into last year to provide immediate COVID stimulus to maintain and improve water networks infrastructure, and to support a partnership investigating the reform of local government water service delivery arrangements.

The work will be undertaken by a specialist civil works contractor Hunter Civil Ltd (HCL). HCL will start work in early August 2021 with work expecting to be completed in June 2022. Residents in the area can expect minor traffic delays on Parkers Road between Awatea Place and Golf Road with construction noise during the day.

Due to the complexity of the work a full road closure will be required for Awatea Place. There will also be restricted vehicle access at times on Parkers Road.

The laying of the sewer pipe along Parkers Road will require closure of the south bound lane of Parkers Road. There will be related closures at the Parkers Road/Golf Road and Parkers Road/Awatea Place intersections.

Some properties on Parkers Road will have their property access affected during the pipe laying works. The contractor will be in touch directly with affected residents closer to the time to make sure property access can be managed.

All roads will remain accessible for emergency services if required.

Further traffic management information will be publicised closer to the time of construction to help residents and the community with their journey planning in the area.


