The amount of grant will be up to \$1,000, however the Committee has some discretion depending on the benefit to a number of businesses.

- Essentials for business operation (directly impacted by the storm event)
- Costs not covered by insurance or other funds such as MSD or IRD support
- Funding will be prioritised for activities that benefit multiple businesses
