

PUBLIC NOTICE OF FURTHER SUBMISSIONS ON PROPOSED PRIVATE PLAN CHANGE 30

Clause 7(1), First Schedule, Resource Management Act 1991 (RMA) Nelson City Council (NCC) gives notice that the Summary of Decisions Requested by Submitters on Proposed Private Plan Change 30 (Nelson Airport Limited Private Plan Change) to the operative Nelson Resource Management Plan is available for inspection at the following locations:

Further Submissions

Further submissions are now invited in support of, or in opposition to, the submissions received from original submitters or those with an interest greater than the general public. A further submission must be limited to a matter in support of, or opposition to, a relevant original submission. A further submission must be in the prescribed form – Form 6 in Schedule 1 of the Resource Management (Forms, Fees and Procedures) Regulations 2003, or like effect.
