Viewpoint Photograph 3C: Located at a clearing at the top of a zig-zag section of walking trail on Botanical Hill's eastern side facing north-east over Kaka Valley towards Malvern Hills and Kaka Hill. **Date:** 28 July 2020 Time: Between 8:00am and 10:00am.



Viewpoint Photograph 3D: Located at the southern end of Sir Stanley Whitehead Walkway, facing north towards a farm access track into the site, the northern end of Botanical Hill, and Sir Stanley Whitehead Walkway thats traverses its western side. **Date:** 26 July 2020 Time: Between 12:00pm and 2:00pm.



Viewpoint Photograph 3E: Located beside a park bench at the northern end of Sir Stanley Whitehead Walkway, facing north towards the gully above Pearce Way, the southern end of Malvern Hills and the Wells Hill to the north.
